We value learning; therefore I will:	<ul style="list-style-type: none"> • Apply existing knowledge to generate new ideas • Evaluate the validity of information presented online • Ask questions and seek help when using school technology • Have a positive attitude and be willing to explore different or new technologies
We value respect for self and others; therefore I will:	<ul style="list-style-type: none"> • Not upload or post personal information, private communications or photos of others without their permission • Respond thoughtfully to the opinions, ideas and values of others • Not send or share mean or inappropriate emails or texts

II. ANTI-BIG BROTHER ACT

The Anti-Big Brother Act mandates that a school district furnishing a student with an electronic device equipped with recording capability must provide the student with "written or electronic notification that the electronic device may record or collect information on the student's activity or the student's use of the device if the device is equipped with a camera, global positioning system, or other feature capable of recording or collecting information on the student's activity or use of the device."

I am aware that all devices received from BOGCHS are capable of recording or collecting information about device activity and use. BOGCHS will not use any of the device's capabilities in a manner that would violate my privacy rights or any individual residing with me. In addition, I am required to comply with all policies and procedures outlined in this Acceptable Use Policy (AUP).

III. INTERNET

It is important that the Internet is used properly so that laws are not broken, others are not offended, and/or school rules are not violated. BOGCHS has taken all prudent actions to block and/or filter access to the Internet for the protection of students as mandated by the Child Internet Protection Act (CIPA).

I will immediately notify a staff member if anyone attempts to initiate any inappropriate personal contact with me, or my peers, while using BOGCHS's Internet access.

I cannot expect privacy in any content stored or accessed through the BOGCHS network. I understand that all Internet activity, including email and websites visited, is monitored and archived.
